Notification Letter Regarding the Protection of Personal Data

("Notification Letter")

Dear Healthcare Professional,

As Johnson & Johnson Medikal Sanayi ve Ticaret Limited Şirketi ("Company"/ "Data Controller"), we value our Company's professional relationships, and we care about your privacy. We would like to inform you about your Personal Data that we collect, use and process for the continuation of our professional relation and to fulfill your needs better as a healthcare professional.

1. Processing of Your Personal Data, Purposes and Legal Reasons

In order to improve our professional relation with you, to better serve your professional needs and to fulfill your requests,

- 1.1. We will process and use your Personal Data (name, surname, e-mail address, institution of employment, title and signature) based on your explicit consent as set forth in paragraph 1 article 5 of the Law on Protection of Personal Data (LPPD) for the following purposes:
 - To organize training activities and meetings, to invite you, to conduct sponsorship activities,
 - To engage in a professional relationship with you and ensure your participation in trainings as a participant or a speaker,
 - To measure the eligibility of in-house selection criteria if you participate in trainings as a participant or a speaker,
 - To manage our database,
 - To answer your questions and to completely fulfill your requests,
 - To send you important information about our services and products as well as our professional relationship,
 - In cases where you allow electronic promotional messages, to provide you promotional information about our products, services and activities through the communication channels of your choice,
 - To conduct analysis to serve you better.
- 1.2. We will process and use your Personal Data (name, surname, title, signature, photograph, video, visual and audio data) based on your explicit consent as set forth in paragraph 1 article 5 of the Law on Protection of Personal Data (LPPD) for the following purposes:
 - Taking your photos, recording your images and/or voices as videos at scientific meetings and/or educational activities held and/or sponsored by the company; recording and using by third party affiliates and third party service providers, making use of your voice and image and recording them in different media such as film, tape, electronic, reuse in accordance with its purpose, combining and using with different materials in accordance with its purpose, to be used for promotional, presentation and information purposes at the stands of the Company in scientific meetings and/or educational activities that it will hold and/or sponsor.
- 1.3. In addition to these, we will process and use your personal data,
 - To notify the authorities related to the field safety action within the scope of making field safety notices by Johnson&Johnson to fulfill the legal obligation given in subparagraph ç, paragraph 2 of article 5 of Law on Protection of Personal Data (LPPD); to keep records in case you are provided with samples; and to make notices to Turkish

Medicines and Medical Devices Agency affiliated to Ministry of Health regarding your participation to the events, and

• In case we have a sponsorship agreement, to make the sponsorship payments related to attendance to the events based on the legal grounds of the performance of the agreement pursuant to subparagraph c, paragraph 2 of article 5 of Law on Protection of Personal Data (LPPD).

If we need to process your personal data for reasons other than those mentioned above, we will notify you in advance and get your consent if required.

2. How We Collect Personal Data

Our company or service providers collect your Personal Data directly from you (written and/or electronically and/or verbally), through our face-to-face meetings, public sources, third parties such as IMS / Cegedim / IQVIA, and/or to our Customer Service through calls. You acknowledge that you have read and understood this Disclosure Statement by consenting the processing of your Personal Data.

3. We share the Personal Data we collect with the following parties:

We share the data you provide to Johnson & Johnson with the following parties - limited to the intended purposes specified in the notification letter:

- Company's domestic group companies to ensure that our internal administrative processes can be carried out by us,
- Our third-party business partners with whom we may offer a co-branded or co-marketed promotion if you have consented to the sending of commercial electronic messages,
- Service providers to carry out communication works,
- Our service providers who provide services to ensure that other services such as database, data analysis, information technology services, customer service, e-mail and direct mail delivery services, auditing and legal services are provided within the scope of defined purposes,
- Our service providers with whom we cooperate to organize online events in case of an event,
- Ministry of Health and, where necessary, to other official institutions and organizations for applications in event approval system in order to fulfill the requirements of the law,
- To the extent permitted by applicable law, we transfer to the other party in the event of a restructuring, merger, sale, joint venture, transfer, or other disposal (or bankruptcy or similar proceedings) of our business, assets or stock

Besides, we may process or transfer your data (a) to comply with the legal processes or applicable laws including the laws outside your country of residence; (b) to respond to the requests from public and government authorities including the officers outside your country of residence pursuant to the applicable law; (c) to fulfill our terms and conditions; and (d) to protect our rights, privacy, security, assets and/or the rights of our subsidiaries, yours, or others. We may process or transfer your data in ways other than those specified upon receiving your consent.

4. Your rights

Regarding the processing of your personal data, you have the following rights:

- Learn whether your personal data have been processed,
- Request relevant information if your personal data has been processed,
- Learn the purpose of personal data processing and whether it has been used for the intended purpose,
- Learn the domestic and overseas third parties to which personal data were transferred,
- Request correction if your personal data was processed incompletely or incorrectly,
- Request to have your personal data deleted or destroyed according to the conditions stipulated in the Law on Protection of Personal Data numbered 6698,
- Request that the third parties to whom your personal data are transferred are notified about the correction of missing or misprocessed personal data or about the deletion or destruction,
- Object to any unfavorable result against you due to analysis of your processed data exclusively by automatic systems,
- Request compensation of loss if any loss is suffered due to the illegal processing of your personal data.

You may state the rights that you wish to exercise, or your requests via an e-mail signed with secure electronic signature to the address <u>privacymdtr@its.jnj.com</u> or apply in person to the address Ertürk Sok. Keçeli Plaza No: 13 Kavacık, Beykoz, Istanbul, Turkey. You may submit the applications you wish to make through registered electronic mail ("KEP") to our KEP address <u>jnj.med@hs01.kep.tr</u>. Your application will be replied free of charge within 30 days. However, you may be charged in accordance with the tariff specified by the Personal Data Protection Board if your application incurs any cost.

Besides, when you want to renounce from receiving commercial electronic messages, you may follow the opt-out directions in the messages sent.

5. Cross Border Data Transfer

We share the data you provide to Johnson & Johnson as limited to the intended purposes specified in the disclosure statement; with Johnson & Johnson's overseas suppliers and overseas group companies of Johnson & Johnson including Johnson & Johnson Services Inc., for which we are the affiliate in Turkey, for the legitimate interests of the data controller as specified in paragraph f, clause 2 of article 5 of the Personal Data Protection Law in order to ensure the execution of our internal administrative processes.
